Criteria for Membership Awards

Honourary Member -

"As bestowed by the membership of the Association through a resolution".

This award may be conferred upon non-members of the Association who have rendered conspicuous service to the Associations, its aims and purposes.

Any member may nominate any person for Honourary Membership but the nomination shall be recommended by the Board of Directors and must receive a majority vote of the members present at the Annual General Meeting.

Honourary Life Member

This award may be conferred upon any person who has rendered conspicuous service to the Association, its aims and purposes.

Any member may nominate any person for Honourary Membership but the nomination shall be recommended by the Board of Directors and must receive a majority vote of the members present at the Annual General Meeting.

Honourary Life Members shall be entitled to participate fully in the affairs of the Association with the exception of holding elected office, serving on the Board of Directors, and voting privileges. Honourary Life Members shall be exempt from payment of annual dues.

Active Life Members

This award shall be conferred upon all past Presidents of the Association and may be conferred upon Active and Associate Members who have retired from the Fire Service, provided they have been members of the Association continuously for ten (10) years, and further provided they are not identified with fire protection commercially, or have become a Chief, Assistant Chief, Commissioner, or Industrial Fire Chief.

This award may be conferred upon non-members of the Association who have rendered conspicuous service to the Associations, its aims and purposes.

Any member may nominate any person for Active Life Membership. Life Membership may be obtained by application to and certification from the Executive Director with unanimous recommendation of the Board of Directors and adopted by a majority vote of the members of the Annual General Meeting.

Life Members shall be entitled to vote unless prohibited by the Constitution, but shall not be entitled to hold elective office or serve on the Board of Directors. Life Members shall be exempt from payment of annual dues.

Nomination Procedure

The Application form shall be completed in its entirety and signed by two members of the Association. It shall be forwarded to:

The nomination papers must be received by the Executive Director not less the one (I) month prior to the date of the Annual General Meeting.

The Executive Director shall forward copies of all the nomination forms received to the members of the Awards Committee not less than two (2) weeks prior to the date of the Annual General Meeting and shall add "Awards" to the agenda of the Pre-Conference Board of Directors Meeting. The members of the Awards Committee shall review the nominations and indicate their recommendation or non-recommendation on the form and fax it to the Chairman of the Awards Committee not less than one (1) week prior to the Annual General Meeting.

The Chairman of the Awards Committee shall, at the Annual General Meeting, read the nomination forms of each nominee receiving the recommendation of the Board of Directors and shall then ask for a show of hands to accept or reject the nomination.

Nominees who are accepted for the position, for which they have been nominated, shall be notified in writing by the President of the Association and shall be sent a certificate indicating their new membership status.
