The Committee's Role and Mandate is to develop strategies relating to labour relations, research, develop initiatives for standards of practice, service delivery, scope of practice, OHS, and policy/procedure.

Collaboration began early in 2020 sharing response standards to COVID-19 as fire services across Saskatchewan were relied on with our highly skilled resources in emergency management and staff trained in Incident Command.

Partnerships strengthened within each jurisdiction with provincial ministries, Saskatoon Public Safety Agency (SPSA), and also with the Canadian Association of Fire Chiefs (CAFC). With this, the Saskatoon Fire Department was honoured to take part as one of eight department representatives interviews discussing pertinent Canadian fire service issues. The document titled Redefining Fire: The Evolving Role of Fire Departments in Canada was released by the CAFC and is a valuable resource for the Fire Service to reflect on.

The Terms of Reference for the Committee was reviewed, updated, and further discussion occurred regarding the mandate of the group.

Meetings with Marlo Pritchard, President SPSA, occurred with the Committee identifying priorities:

- Training and Certification
- Codes Standards
- Emergency Management Support
- Enable Regional Partnerships
- Public Educator

The Pandemic has created opportunities to meet through online platforms which has created valuable conversations. The Committee looks forward to the year ahead and being part of a coordinated effort to strengthen relationships with SPSA.

In the first meeting after the interim nomination, an election was held virtually to elect a chair. During the annual chief's conference, an additional election was held for all open positions and, we are pleased to announce and are excited to work with the following individuals elected to the board:

In an investigative discussion with the Saskatchewan Public Safety Agency to find who or if there was an SPSA staff assigned to public education, it was quickly recognized that there was a disconnect between our division and the province. SPSA Public Education Oversite, Executive Director of Enterprise Projects and External Relations Karri Kempf, was unaware that they could be involved or that there was a public education division of the SAFC. We discussed opportunities and collaborative efforts for us to better serve the Province of Saskatchewan, specifically regarding youth and school initiatives.

SPSA and the SAFC public education division are excited to announce a joint effort to provide a fire safety comic book to every kindergarten through grade five student in the province. These comic activity books are designed and drawn by a Saskatchewan artist with the art, storyline, and characters being specific to our province. We are excited to be reaching almost 100,000 Saskatchewan youth with fire safety education material, regardless of location or financial ability, as the books will be free of charge. Funding for the program will come primarily from the SPSA, with the remainder funded by contributions from individual fire departments.

We are excited to see an uptick in the attendance of departments using virtual methods with the hope build on this momentum through 2021 and into the future.

Management is responsible for the preparation and fair presentation of these financial statements in accordance with Canadian accounting standards for not-for-profit organizations and for such internal control as management determines is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is responsible for assessing Saskatchewan Association of Fire Chiefs Inc.'s ability to continue as a going concern, disclosing, as applicable, matters relating to going concern and using the going concern basis of accounting unless management either intends to liquidate Saskatchewan Association of Fire Chiefs Inc. or to cease operations, or has no realistic alternative but to do so.

Those charged with governance are responsible for overseeing Saskatchewan Association of Fire Chiefs Inc.'s financial reporting process.

Auditors' Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance, but is not a guarantee that an audit conducted in accordance with Canadian generally accepted auditing standards will always detect a material misstatement when it exists. Misstatements can arise from fraud or error and are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of these financial statements. As part of an audit in accordance with Canadian generally accepted auditing standards, we exercise and maintain professional skepticism throughout the audit. We also:

- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, design and perform audit procedures responsive to those risks and obtain audit evidence that is sufficient and appropriate to provide a basis for our opinion. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control.

- Evaluate the overall presentation, structure and content of the financial statements, including the disclosures and whether the financial statements represent the underlying transactions and events in a manner that achieves fair presentation.

We communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit and significant audit findings, including any significant deficiencies in internal control that we identify during our audit.

NOTES TO FINANCIAL STATEMENTS

FOR THE YEAR ENDED DECEMBER 31, 2020

1. THE ORGANIZATION

The Saskatchewan Association of Fire Chiefs Inc. was incorporated on March 18, 1989 under the Non-Profit Corporations Act of Saskatchewan. The association promotes fire prevention, fire safety and life safety in the province of Saskatchewan. As a non-profit organization, the association is not subject to income taxes.

2. SIGNIFICANT ACCOUNTING POLICIES

The financial statements were prepared in accordance with Canadian accounting standards for not-for-profit organizations and include the following significant accounting policies:

Financial Instruments

The association initially measures its financial assets and liabilities at fair value adjusted by, in the case of a financial instrument that will not be measured subsequently at fair value, the amount of transaction costs directly attributable to the instrument.

The association subsequently measures all financial assets and financial liabilities at amortized cost except for investments in equity instruments that are quoted in an active market, which are measured at fair value. Changes in fair value are recognized in deficiency of revenue over expenditures for the year.

Financial assets measured at amortized cost include cash, term deposits and accounts receivable.

Financial liabilities measured at amortized cost include accounts payable and accrued liabilities and payroll deductions payable.

Financial assets measured at cost are tested for impairment when there are indicators of impairment. The amount of any write-down is recognized in net earnings for the year. The previously recognized impairment loss may be reversed to the extent of the improvement, directly or by adjusting an allowance account, provided it is no greater than the amount that would have been reported at the date of the reversal had the impairment not been recognized previously. The amount of the reversal is recognized in net earnings for the year.

Tangible Capital Assets and Depreciation

Tangible capital assets are recorded at cost and amortized over their estimated useful lives. This requires estimation of the useful life of the asset and its salvage and residual value. When management considers that a tangible capital asset no longer contributes to the organization's ability to provide services, its carrying amount is written down to its residual value. As is true of all accounting estimates, it is possible that changes in future conditions could require changes in the recognized amounts for accounting estimates. Should an adjustment become necessary, it would be reported in earnings in the period in which it became known.

2. SIGNIFICANT ACCOUNTING POLICIES (continued)

Depreciation of tangible capital assets is calculated using the straight-line method at the following annual rates:

Furniture and equipment	10%
Computer equipment	20%
Trailer	10%

Depreciation on assets acquired during the year is recorded at the full annual rate. There is no depreciation recorded in the year of disposal.

Revenue Recognition

The association follows the deferral method of accounting for contributions. Restricted contributions are recognized as revenue in the year in which the related expenditures are incurred. Unrestricted contributions are recognized as revenue when received or receivable if the amount to be received can be reasonably estimated and collection is reasonably assured.

SAFC conference revenue and membership fees are recognized as revenue when earned and when the amount to be received can be reasonably estimated and collection is reasonably assured.

Special event fundraising revenue is recognized as the applicable event is held.

Donated Material and Services

The association benefits from the donation of materials and services from its members. These financial statements do not reflect the value of these donations in kind since a fair value cannot be reasonably estimated.

Use of Estimates

The preparation of the financial statements in conformity with Canadian accounting standards for not-for-profit organizations requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities at the date of the financial statements and the reported amounts of revenue and expenditures during the year. Significant items subject to estimate and assumption include the estimated useful lives of tangible capital assets. Actual results could differ from estimates.

8. FINANCIAL RISK

Liquidity Risk

Liquidity risk is the risk that the association will not be able to meet its financial obligations as they become due. Liquidity risk also includes the risk of not being able to liquidate assets in a timely manner at a reasonable price. The association is subject to liquidity risk on its liabilities. The association manages its liquidity risk by budgeting future cash flows and by monitoring cash resources and by keeping significant cash reserves in place. As described in note 9, the liquidity risk has continued to be higher than normal as a result of the current health crisis created by the COVID-19 virus and its economic impact.

9. UNCERTAINTY DUE TO THE COVID-19 HEALTH ISSUE

In March 2020 the World Health Organization declared the outbreak of a novel coronavirus (COVID-19) as a global pandemic, which continues to spread in Canada and around the world.

Management is uncertain of the effects of these changes on its financial statements and believes that any disturbance may be temporary; however, there is uncertainty about the length and potential impact of the disturbance.

As a result, we are unable to estimate the potential impact on the association's operations as at the date of these financial statements.




